Letter of Finding: Action Summary Report National School Lunch Program Administrative Review Effort (NSLP AR)

First review conducted at SAU #28 on May 16-17, 2017.

This document represents written notification regarding the findings of the administrative review with required corrective action and timeframes. Upon further examination of the documents and review of requested information following the AR, there may be additional technical assistance or findings requiring corrective actions.

This information should be shared with the appropriate administrative personnel.

Key terms:

- **Findings**: the area reviewed was found to be out of compliance based on federal and/or state regulation. A plan of Corrective Action is required.
- **Technical Assistance** (TA): guidance and recommendations provided to improve and strengthen overall operations and systems for increased efficiency and accuracy.
- Corrective Action (CA): Federal and/or State regulation compliance errors
 mandating follow-up corrections with a timeframe for completion. Some Corrective
 Action plans may also include a possible fiscal action. Failure to respond and provide the
 necessary corrections may result in the holding of a claim.
- **Fiscal Action** (FA): recovery of overpayment due to errors in critical review areas associated with federal dollars or repeat Findings.
- **Recommendation**: The review area did not rise to a required Corrective Action Plan, but there were operational or managerial systems that the State agency felt could use review and consideration.
